- Strong analytical skills

- Should enjoy working in a fast paced, startup environment
- Willing to travel across Mumbai and Bhiwandi
- Possess high levels of ownership and ability to learn on the go
- Should be able to deal with the uncertainty that comes with solving complex social issues with a strategic, systemic lens
- Knowledge about the first 1000 days preferred, not compulsory.

- Manage a team of 40+ field workers by empowering the leadership of the Managers
- Implementing through the team practices to ensure maximum participation of community members in FMCH's health and nutrition programs
- Technical support for the team ensure that project team understands local health, social and nutrition issues and can articulate them
- Ensure that team follows FMCH core values while conducting themselves within the team and with beneficiaries
- Support the managers in ensuring community participation and imparting actionable knowledge through the community officers

Communication

- Regular team meetings to ensure smooth communication at all levels
- Present the field reports to the Board and the Management team every quarter/month
- Interactive with all level of staff including consultants

- Oversee the admin functions of the team and provide needed support
